	DUAL Member	Shall be an ordinary or full capitated member of another club affiliated with Bowls WA or with a similar Association in any other Australian State or Territory. They shall be entitled to all privileges of the Club but shall not be eligible: <ul style="list-style-type: none"> <li>- To stand for any office or propose or second any applications for membership or vote;</li> <li>- To play in any pennant matches for the Club unless the members' home club does not enter a side in a defined Bowls WA pennant competition;</li> <li>- To represent the club or play in Club championship events</li> </ul>	\$10
GUESTS	Financial Members may introduce guests to the Club at any time provided that: a) The Guests shall not exceed five (5); b) A Guest shall not be supplied with liquor in the club premises except on the invitation and in the company of the member; c) A guest shall be supplied with liquor to be consumed only on the club premises; d) A member introducing a guest shall be responsible for the proper conduct of the guest(s) whilst on the premises; e) At the expense of the member, and the with approval of the Committee, a member may supply liquor to guests, without limitation as to number, at a private function held by or on behalf of that member at the Club premises.
